EXPLANATIONS

- 1. Country groups, grant amounts, and calculation method were referred to guidebook published by National Agency for 2018 project period.
- 2. Erasmus+ Traineeship Mobility must be finished till May 31, 2020 at the latest.
- 3. There will not be an additional payment for flight ticket, accommodation or insurance. These expenses will be met by the students individually.
- 4. %70 of Erasmus grant is paid before the mobility, and %30 after the mobility when the process is completed without any missing transaction.
- 5. If traineeship is not completed or the trainee does not comply with the responsibilities, then IUE has the right to ask the reimbursement of the grant payment made before.
- **6.** Students who want use Erasmus intern as compulsory internship, may get in contact with their intern commission and run the procedure as it is required. The procedures that is related with compulsory internship are not executed by the Office of International Affairs.

7. Documents to be submitted prior to departure

- Learning agreement for Traineeship-Before Mobility
- Valid Copy of the Visa
- Euro bank account
- Insurance that covers the traineeship period (Insurance policy must cover accident insurance, health insurance, and liability insurance)
- Online Language Support (OLS) Exam result

8. Documents to be submitted at the end of the mobility

- Learning agreement for Traineeship-After Mobility
- Document on the evaluation of the placement abroad by the host institution
- Participation Certificate
- Online EU Questionnaire
- Online Language Support (OLS) Exam result
- 9. The students who want to withdraw their application, even with or without grant, are required to submit a letter to Office of International Affairs explaining their reason of withdrawal until 4.11.2019 at the latest.
- 10. In the next round of applications, there will be a decrease in Erasmus+ score of students who withdraw their application after the deadline even if they are provided with or without grant.
